PRIVACY ACT ACKNOWLEDGEMENT

- I (being the person named below) understand** that all personal information (“personal information”) MyFinance (a division of Instant Finance Limited), (“you”) holds about me, whether now or in the future, will be used for any or all of the following purposes:

 - accessing name and address or other information about me from NZTA or from any public register including the Register of Drivers Licences and the Motor Vehicle Register, and doing so even if I have previously advised the Motor Vehicle Register or other register that I did not want information held by it to be disclosed;
